

WARRANTY AND DISCLAIMER - AVDS hereby warrants the programming described in the Schedule included in any purchase agreement for a period of one year from the date the system licenses are downloaded from provider's web site to Customer's servers. AVDS acknowledges that the implied warranty of merchantability and/or implied warranty of fitness for a particular purpose may be created by law by virtue of the sale thereof.

AVDS further warrants that it has good and marketable title to the equipment and software in the attached Schedule and that such equipment and software are free from all liens and encumbrances, or any other claims of third parties. AVDS agrees to execute any and all documents which Customer deems necessary to effectuate such transfer of title.

AVDS does not warrant and is not responsible for the equipment and software, which are subject to the terms and conditions and warranty provisions of the Interactive License Agreement between Customer and Genesys.

During the warranty period and thereafter, maintenance or service work performed on the software by others not designated by AVDS during the warranty period, without written consent of AVDS shall cause this Agreement to become null and void. In addition, if any procedure or work is performed by the Customer not under the direction of AVDS remotely or locally, and results in software failure, subsequent intervention by such remedial work will be billable at AVDS' prevailing rates.

AVDS'S OBLIGATIONS FOR BREACH OF ANY WARRANTY, EXPRESSED OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND/OR FITNESS FOR A PARTICULAR PURPOSE, SHALL BE LIMITED TO REPAIRING OR REPLACING EQUIPMENT AND/OR SOFTWARE AT ITS OWN EXPENSE, WHICH SHALL BE CUSTOMER'S EXCLUSIVE REMEDY AND AVDS SHALL NOT BE LIABLE FOR CONSEQUENTIAL AND/OR LIQUIDATED DAMAGES, MISUSE, THEFT, VANDALISM, FIRE, WATER, ACTS OF GOD, AND/OR BY UNAUTHORIZED WIRING, REPAIR, RELOCATION AND/OR ALTERATION. Additional Warranty from Genesys -

(a) Genesys warrants that the Licensed Software, as delivered by Genesys and when used in accordance with the Documentation, will substantially conform to the Documentation for a period of ninety (90) days from delivery.

(b) If the Licensed Software does not comply with this warranty and such non-compliance is reported by Customer to Genesys within the ninety (90) day warranty period, Genesys will do one of the following, at Genesys' reasonable discretion: either (i) use reasonable efforts to repair the Licensed Software, (ii) replace the nonconforming Licensed Software, or (iii) terminate the license and refund the relevant license fees paid for such non-compliant Licensed Software. The above warranties specifically exclude defects resulting from accident, abuse, unauthorized repair, modifications or enhancements, or misapplication. Any refund provided hereunder shall be deemed a revocation of the license granted for such refunded Licensed Software.

(c) If Genesys provides Customer tangible media for Licensed Software, Genesys warrants that the media upon which the Licensed Software is recorded will not be defective under normal use, for a period of ninety (90) days from delivery. Genesys will replace any defective media returned to it within the warranty period at no charge to Customer.

(d) Genesys warrants that it shall provide Maintenance and Support and Services in a professional and workpersonlike manner.
